

Funding Agreement

This Agreement is made this 6th day of November, 2020 by and between **NORTH LAKE COUNTY HOSPITAL DISTRICT, an independent special taxing district of the County of Lake, State of Florida** referred to herein as “North Lake County Hospital District”, and **LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL, a licensed hospital/ provider** referred to herein as “LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL”.

Whereas, the North Lake County Hospital District was recreated and the charter was reenacted under House Bill 1299, which is codified at 2012 Florida Laws Ch. 258 as the North Lake County Hospital District Act, and the District was established as an independent special taxing district in the County of Lake, State of Florida; and

Whereas, the Act and House Bill 1299 defines the public purpose of the district is to provide a means to pay for indigent care provided in accordance with this act through the use of health care facilities not owned and operated by the board of trustees; and

Whereas, the Act and House Bill 1299 states the District may make and execute contracts and other instruments necessary in the exercise of its powers under this act and do all things necessary to carry out the purpose of this district; and

Whereas, the permitted use of tax funds consistent with the public purpose of the district may be used to pay for indigent care provided by licensed hospitals physically located in the district that are approved by the board of trustees; and

Whereas, LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL is a licensed hospital physically located in the district as more specifically described in the Act and House Bill 1299 and provides care for the indigent; and

Whereas, the North Lake County Hospital District has accepted the request of the LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL for the allocation of funds, approved LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL as a licensed hospital in the District and wishes to provide funds for the purposes and only for the purposes set forth in said request and this Agreement.

Now, Therefore, in consideration of the premises and the mutual representations, warranties, covenants and agreements herein contained, the parties hereby agree as follows:

A. North Lake County Hospital District shall not provide LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL with funds for indigent care of residents of the defined district in excess of the actual costs of providing care; however, the payment for indigent care provided may not exceed the amount payable by the Medicare program for identical or substantially similar care in the territory of the District.

B. LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL agrees as a condition of accepting said funds from the district to be subject to an audit of its records relative to the patients for whom payment is sought in order to ensure compliance with the Act and House Bill 1299 and to provide transparency and accountability.

LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL understands and agrees that all audit

reports shall become public records upon acceptance by the Board of Trustees.

C. If, upon completion of any audit, it is determined that payment was made by the District that was not in compliance with the requirements of the Act and House Bill 1299, a rebuttable presumption is created that the District is entitled to a recoupment of the amounts in question.

In accordance with the Act, notice shall be provided to LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL and an opportunity to go forward with evidence rebutting the presumption in an informal setting shall be provided. Pending any judicial determination, the district may set off the amounts in question against any other amounts owed or to be owed to the provider. If informal resolution cannot be reached between the parties, the Board of Trustees shall request a formal mediation conference.

D. LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL agrees to ensure that all recipients of indigent care for which payment is sought under the criteria of the Act and House Bill 1299 are qualified by the provider as medically indigent persons and residents of the district described in the act.

E. LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL agrees to certify that any indigent care for which payment is requested in whole or part from the District is medically necessary.

F. LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL agrees to certify, under penalty of perjury, that the eligibility verification procedures adopted by the Board of Trustees have been complied with and that he or she, in good faith, believes that the person is qualified to receive indigent care.

G. LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL agrees if estimated payments are received from the District, the Hospital shall maintain such funds in a separate accounting of funds and document each eligible indigent care patient account. All direct documentation that is part of the audit record is subject to disclosure under Chapter 119, Florida Statutes.

H. LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL as a licensed hospital/provider agrees to comply with the policies and requirements adopted by the North Lake County Hospital District.

I. Provided all obligations of LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL as described above are met and continue to be met, an amount not to exceed the sum of FOUR MILLION THREE HUNDRED SIXTY-ONE THOUSAND, NINE HUNDRED THIRTY-SIX AND NO/100THS DOLLARS (\$4,361,936.00) shall be distributed to LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL by the North Lake County Hospital District

J. The term of this Agreement shall commence on the 1st day of July, 2020 and shall continue to the 30th day of June, 2021.

K. If either party shall breach or fail to perform any requirement or provision of this Agreement, the non-breaching party shall give the breaching party 60 days notice of intent to terminate the Agreement, which notice shall specify the nature of the alleged breach. If the breaching party fails to correct the breach within the 60-day notice period, the non-breaching party may immediately terminate this Agreement at the end of the notice period, or take such actions and pursue such remedies as provided by law, or both. No remaining funds will be paid after termination of this Agreement. If at any time LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH

LEESBURG HOSPITAL fails to maintain or meet the obligations outlined in the Agreement, this Agreement shall be considered terminated and any monies paid in error shall be repaid to the North Lake County Hospital District within 60 days of the termination of this Agreement.

L. Each party (“Indemnifying Party”) shall indemnify, defend and hold harmless the other party (“Indemnified Party”), its officers, directors, shareholders, employees, agents and affiliates from and against any and all claims, liability, damages and/or costs (including, without limitation, reasonable attorney’s fees and expenses) Indemnified Party may incur as a result of claims in any form by third parties related to or arising out of (a) Indemnifying Party’s performance of, or failure to perform, any obligation under this Agreement, or (b) the material untruth of, or Indemnifying Party’s failure to observe, any representation given to the Indemnified Party in connection with this Agreement.

M. LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL agrees that any funds received under this Agreement used other than as set forth in the Act and House Bill 1299 will be immediately refunded to the District.

N. All notices, demands, or other writings required to be given or made or sent pursuant to this Agreement, or which may be given or made or sent, by either party, shall be made or sent in writing and addressed as follows:

P. North Lake County Hospital District and LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL warrants and represents that they have full power and authority to enter into this Agreement and to carry out its obligations hereunder. The execution and delivery of this Agreement and the consummation of the transactions contemplated hereby have been duly and validly authorized and no other corporate acts or proceedings on the part of North Lake County Hospital District and LEESBURG REGIONAL MEDICAL CENTER, INC. D/B/A UF HEALTH LEESBURG HOSPITAL are necessary to authorize this Agreement or to consummate the transactions contemplated hereby and this Agreement constitutes a valid and legally binding obligation of the parties.

Q. This Agreement incorporates and includes all prior negotiations, correspondence, conversations, agreements, or understandings applicable to the matters contained herein and the parties

agree that there are no commitments, agreements, or understandings concerning the subject matter of this Agreement that are not contained in this document. Accordingly, it is agreed that no deviation from the terms hereof shall be predicated upon any prior representations or agreements, whether oral or written.
